



CITY OF GIBRALTAR NOTICE OF BID PROPOSALS

Sealed bid proposals will be accepted at the Office of the City Clerk, 29450 Munro, Gibraltar, MI 48173 until **10:00 a.m. on September 13, 2023** for the following:

“FIREWORKS DISPLAY”

Display to be on **July 4, 2024** with an alternate rain date of July 5, 2024 in the event of inclement weather. Interested bidders are to submit proposals as follows:

1. Display information: Bidders are to submit a description of the type of display to be presented, including the type, number, time length, and, if possible, pictorial of the mortars to be used.
2. Identify the pyrotechnic team, their certification and training.
3. **The City would like proposals for a show costing \$15,000.00.** A selection on the preferred show will occur after bids are received. Bid selection will be based upon the available budget, the sizes and the amount of shells to be fired, and the estimated time length of the show.
4. Bidders are to submit names, addresses and phone numbers of other communities or organizations for whom the bidder has done displays in the past.
5. Describe the equipment to be utilized in discharging mortars; and whether such equipment is required to be certified by the State of Michigan.
6. Bidders must enclose evidence of insurance or ability to obtain insurance under Aggregate in the amount of not less than 5 million (\$5,000,000) dollars. Must provide for bodily injury and property damages for “Gibraltar’s Fireworks Only.” Valid certificates covering July 4th and 5th, 2024 must be provided no later than July 1, 2024.
7. The City of Gibraltar and the Gibraltar School District must be named as additionally insured parties on said policy.
8. Contract for awarding bid will require that the vendor hold the City of Gibraltar and the Gibraltar School District harmless for any injury or damages resulting from the display.
9. Successful bidder must provide perimeter security to assure that bystanders are not in close proximity to the operation so as to avoid any injury.

General Information:

1. The display area is centered on or about the Gibraltar School District property at Parsons Elementary School, 14473 Middle Gibraltar Rd., 365 feet from residential area on the north and south side.
2. Bidders are encouraged to visit the site prior to bidding.
3. The City of Gibraltar reserves the right to waive any defects in proposals and/or bids. The City of Gibraltar reserves the right to award the bid in the best interest of the City. The City of Gibraltar reserves the right to reject any and all proposals
