TO THE QUALIFIED ELECTORS OF THE CITY OF GIBRALTAR:

PLEASE TAKE NOTICE that any qualified elector of the City of Gibraltar who is not already registered, may register to vote at the office of the City Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at mi.gov/vote and mailed to the City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, October 21, 2024**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497) at the Gibraltar City Clerk's Office, located at 29450 Munro St., Gibraltar, MI 48173 at the following times:

- Regular business hours: Monday through Friday from 8:00 a.m. to 4:00 p.m.
- Saturday, November 2, 2024 from 8:00 a.m. to 4:00 p.m.
- Election Day, Tuesday, November 5, 2024 from 7:00 a.m. to 8:00 p.m.
