**PLEASE TAKE NOTICE** that the following proposals will also appear on the ballot:

- Gibraltar School District – Operating Millage Renewal Proposal – Continue to levy the statutory limit of 18 mills (\$18.00 on each thousand dollars of taxable valuation) for ten years (2025 through 2034) in the event of future Headlee rollbacks of up to 3 mills, for non-homestead properties.

- Gibraltar School District – Building and Site Sinking Fund Millage Renewal Proposal – Levy .50 mills (about 50 cents per thousand dollars of taxable valuation) for ten years (2025 through 2034).
- Wayne County RESA Renewal of Regional Enhancement Millage Proposal – Increase by 1.9812 mills (\$1.98 per thousand dollars of taxable value) for six years (2028 to 2033).
